## Strengthening Pathology Laboratory Based Surveillance of Cancers in Sri Lanka

Surveillance of cancer is an essential strategy for planning, implementation and evaluation of evidence based cancer control programmes. The National Cancer Control Programmme (NCCP) has been monitoring trends of cancers in Sri Lanka since 1985 and has been publishing the national cancer registry.

For the surveillance of cancers, cancer incidence data are extracted from cancer patients clinic files maintained at the cancer treatment centres in Sri Lanka. From year 2000 onwards, newly diagnosed cancers are reported from pathology laboratories throughout the country to supplement the cancer incidence data from both government & private sector hospitals & pathology laboratories. Consultant histopathologists, haematologists & directors of the hospitals supported this activity for more than 10 years. Pathology laboratory based cancer surveillance mechanism needs to be further strengthened to improve coverage & comphrensiveness.

Following information will be helful in strengthening pathology laboratory based cancer surveillance. The modified format of Cancer Return Form 1 (Annex 1) which is used for Pathology Laboratory Based Cancer Surveillance contains following variables as shown in table 1.1.

The Medical Officer, Nursing Officer or Medical Laboratory Technician can extract these data from individual histology/cytology reports maintained at the Hitopathology or Haematology laboratories. Each filled form needs to be signed by the officer – in - charge of this activity and certified by the Consultant Histopathologist / Consultant Haematologist.

Since personal identification data is included, confidentiality of data has to be compulsorily maintained throughout the process. National Cancer Control Programme would not release personal identification details in the reports generated using these data.

The filled forms have to be posted to the following address monthly. It will be appreciated if the filled forms of the previous month are sent before the end of next month.
