**Assessment of Diagnosis & Treatment Facilities for Cancer Care in Sri Lanka through IAEA-PACT & WHO Country Programme Review**

Through the Programme of Action for Cancer Therapy (PACT) of International Atomic Energy Agency (IAEA) & World Health Organization (WHO) in the year 2008, a comprehensive review of Cancer Control Programme was conducted in Sri Lanka with the participation of international experts in cancer control with the Sri Lankan counterparts. Since it has elapsed 10 years after the previous review of cancer control programme, it is expected to conduct a repeat country programme review by the IAEA PACT & WHO with the active participation of international experts and local counterparts.

As a preparation to the country programme review, it is expected to conduct series of country situation analysis related to cancer control. Already some of the pre-assessment tools were completed. The next tool to be filled is **impACT Review Questionnaire on Diagnosis & Treatment** for each Radiotherapy /Nuclear Medicine / Mammography /Medical Oncology centres.

The **impACT Review Questionnaire** is herewith attached. Please consider this questionnaire is an internationally agreed format developed by IAEA/PACT & WHO. Some questions may not be applicable to your institution.
